## **Official Rules**

## No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- 1. Eligibility: This sweepstakes (the "Sweepstakes") is open only to legal residents of the United States who are at least eighteen (18) years old. Employees of Outschool, Inc.
