

## Official Rules

### No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

1. **Eligibility:** This sweepstakes (the “Prize draw”) is open only to legal residents of the United Kingdom who are at least eighteen (18) years old. Employees of Outschool, Inc. (“Sponsor”), as well as the immediate family (spouse, parents, siblings, and children) and household members of those employees, are not eligible to enter.
2. **Entry Period:** The Prize draw begins at 08:00 GMT on 24th November 2022 and ends at 23:59 GMT on 4th December 2022 (“Entry Period”). Entries submitted before or after the Entry Period will not be eligible. Sponsor’s computer is the official time-keeping device for the Prize draw.
3. **How to Enter:** To participate, you must have one of the following social media accounts - Facebook, Instagram, TikTok, YouTube - and it must be set to “public.” To enter, you will need to make a public social media post (not a story that disappears within 24 hours) telling your followers what your child’s favourite online/video game or board game is, and tag @outschool and use the hashtags #outschooluk and #prizedraw. When you do, you will receive one (1) entry (“Entry”). There is a limit of one (1) Entry per person, and you may not use multiple Outschool accounts to enter. Sponsor may disqualify any entrant that attempts to enter more than one (1) time. By entering, you indicate your full agreement to these Official Rules and Sponsor’s decisions regarding the Prize draw, which are final and binding.
4. **Drawing:** By no later than 10th December 2022, Sponsor will select 1 (one) potential winner in a random drawing of all entries received. The odds of being selected depend on the number of entries received.
5. **Potential Winner Requirements:** Where applicable, a potential winner may be required to sign and return to the Sponsor information for eligibility, publicity, or taxes, where applicable. If a potential winner fails to sign and return these documents within the required time period, an alternate potential winner may be selected in his/her place in a random drawing of all remaining entries received. If the potential winner fails to respond within 24 hours or if the notification is returned as undeliverable or fails to reach the potential winner for any reason, the potential winner will be disqualified and an alternate winner may be selected at Sponsor’s sole discretion, who will be subject to disqualification in the same manner.
6. **Prizes:** The prize for this Prize draw is a Nintendo Switch OLED Model Pokemon Scarlet and Violet Limited Edition, with a RRP of £319 (the “Prize”). A winner is responsible for paying any applicable income taxes and any and all other fees, costs and expenses not listed above. Any Prize details not specified above will be determined by Sponsor, in its sole discretion. A Prize may not be transferred and must be accepted as awarded, and any difference between approximate and actual Prize value will not be awarded. A winner may not request cash or a substitute prize; however, Sponsor reserves the right to substitute a Prize with another prize of equal or greater value if the Prize is not available for any reason, as determined by Sponsor, in its sole discretion.
7. **License Grant to use Entry:** By entering the Prize draw, you grant Sponsor, its agents, licensees, and assigns, an irrevocable, perpetual, worldwide, royalty-free, non-exclusive right and permission to reproduce, encode, store, copy, transmit, publish, post, broadcast, display, publicly perform, adapt, modify, create derivative works of, exhibit, and otherwise use your Entry as-is or as-edited (with or without your name, image and likeness) in any media throughout the world for any purpose, without limitation, and without additional review, compensation or approval from you.
8. **General Conditions:** In the event that the operation, security, or administration of the Prize draw is impaired in any way, Sponsor may, in its sole discretion, either: (a) suspend the Prize draw to address the impairment and then resume the Prize draw in a manner that best conforms to the spirit of these Official Rules; or (b) award the Prize(s) at random from among the eligible entries received up to the time of the impairment. Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the operation of the Prize draw, violates these Official Rules, or acts in an unsportsmanlike or disruptive manner. Sponsor reserves the right to seek damages from any person who seeks to undermine the legitimate operation of the Prize draw. Failure by Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to

Sponsor by mail shall not be deemed proof of receipt of that communication by Sponsor. The Prize draw is subject to local laws and regulations and is void where prohibited.

9. **Sponsor:** The Prize draw is sponsored by Outschool, Inc., 2261 Market Street #4545, San Francisco, California 94114. The Prize draw is not sponsored by, endorsed by, administered by, or associated with Instagram, Facebook, Apple, Google, and Nintendo.
10. **Release and Limitations of Liability:** By entering, you agree to release and hold harmless Sponsor, Instagram, Facebook, Apple, TikTok, Google, and Nintendo and each of its respective parents, subsidiaries, affiliates, officers, directors, employees, and agents (collectively, the “Released Parties”) from and against any claim or cause of action arising out of or related to participation in the Prize draw or receipt or use of any Prize, including, but not limited to (a) unauthorized human intervention in the Prize draw; (b) technical errors related to computers, servers, providers, or telephone or network lines; (c) technical errors that may prevent an individual from participating or receiving direct messages related to the Prize draw; (d) printing errors; (e) lost, late, postage-due, misdirected, or undeliverable mail; (f) errors in the administration of the Prize draw or the processing of posts; or (g) injury or damage to persons or property. You further agree that in any cause of action, in no event shall the Released Parties be liable for legal fees or other legal costs. You waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, or indirect damages. All potential winners are subject to verification by Sponsor, whose decisions are final and binding in all matters related to this Prize draw. An entrant is not a winner of any Prize, even if the Prize draw should so indicate, unless and until entrant’s eligibility and the potential winning Entry has been verified and entrant has been notified that verification is complete. Sponsor will not accept alternative evidence of winning in lieu of its validation process.
11. **Disputes:** You agree that any and all disputes, claims and causes of action arising out of, or connected with, the Prize draw or any Prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by arbitration pursuant to the rules of the International Centre for Dispute Resolution. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of the Sponsor in connection with the Prize draw, shall be governed by, and construed in accordance with, the laws of California, without giving effect to any choice of law or conflict of law rules (whether of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than California.
